### ***SECTION (1) DUES***

(b) Dues are payable in advance before the first of January. Any dues not paid prior to the February membership meeting shall become delinquent and the member shall stand suspended.

(c) New members joining the Club will pay an application fee of twenty (\$20.00) dollars plus the yearly dues.

(d) New member's dues will be adjusted by quarters for the month they joined the Club:

1st. Quarter - Jan., Feb. And Mar. 100% (full amount)

2nd. Quarter - April, May And June 75%

3rd Quarter - July, Aug. And Sept 50%

4th. Quarter - Oct., Nov. And Dec. 25%

Dues will then be paid on a yearly basis starting the following January.

### ***SECTION (1) DUES***

(c) Dues are payable in advance before the first of **October**. Any dues not paid prior to the **November** membership meeting shall become delinquent and the member shall stand suspended.

(d) New members joining the Club will pay an application fee of twenty (\$20.00) dollars plus the yearly dues.

(e) New member's dues will be adjusted by quarters for the month they joined the Club:

1st. Quarter - **Oct., Nov. And Dec.** 100% (full amount)

2nd. Quarter - **Jan., Feb. And Mar** 75%

3rd Quarter - **April, May And June** 50%

4th. Quarter - **July, Aug. And Sept** 25%

Dues will then be paid on a yearly basis starting the following **October**.
